Privacy Notice for Students

1. About us, this updated document and your data

Chaucer College is an education provider specialising in classroom based and online English language courses for students from countries worldwide.

Chaucer College acknowledges that Britain's exit from Europe and the European Court of Justice's invalidation of the EU-US Privacy Shield has significant implications for data protection law and practice. This updated privacy notice reflects those developments and affirms Chaucer College's commitment to protecting personal data and upholding individual's data protection rights.

This updated privacy notice is to inform you about how we use your personal data. It is important that you read this privacy notice together with any other privacy notice or fair processing notice we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data.

2. Appointment of an EU Representative

Chaucer College's classroom-based services are available to and may be taken up by citizens in the EU, but our courses are not 'offered' to those EU data subjects in the manner described by the European Data Protection Board. We have not therefore appointed an EU Representative.

Where our online services might reasonably be described as being offered to EU citizens, any related processing can properly be described as occasional and does not include the large-scale processing of special category data or data relating to criminal convictions or offences. As such, little risk to the rights and freedoms of natural persons is presented by our data processing in relation to online courses.

If you would like to discuss our decision not to appoint an EU Representative, please do not hesitate to contact us (see below). This decision will be kept under review in step with our evolving business practices.

3. Data Protection Officer

5. Recipients or categories of recipients of the personal data

Where it is legally required, or necessary for another reason allowed under data protection law, we may share personal information about you with:

- Our local authority to meet our legal duties to share certain information with it
- The Department for Education (a government department)
- Your family and representatives
- Fee payers
- Educators and examining bodies
- A trusted educational agent in your country to help you during the application process
- Our regulators (British Council, English UK)
- Suppliers and service providers so that they can provide the services we have contracted them for, such as online satisfaction surveys, transfer or taxi companies, excursion providers
- Financial organisations
- Central and local government
- Our auditors

- Health authorities
- Security organisations
- Health and social welfare organisations
- Professional advisers and consultants
- Charities and voluntary organisations
- Police forces, courts, tribunals
- Professional bodies

Chaucer College acknowledges that the ICO has published an updated Data Sharing Code and that we must comply with its points of best practice. It is also acknowledged that we may only share children's data if we can demonstrate a compelling reason to do so, taking account of the best interests of the child.

6. The details of transfers of the personal data to any (other) third countries or international organisations

Chaucer College stores some personal data on third party cloud based storage systems and servers. These providers are data processors that process data on our behalf by way of providing secure online storage space and services. They include:

- Microsoft Corporation
- Sage
- Adobe Incorporated

The use of these processors may mean that your data is transferred to other third countries outside of the UK. When transferring data to other third countries or organisations, we ensure appropriate and suitable safeguards and technical measures are in place to protect your personal data (e.g., standard contractual clauses). Chaucer College acknowledges the invalidation of the US Privacy Shield as a suitable safeguard when transferring personal data.

7. The retention periods for your personal data

We will keep personal information about you while you are a student at our school. We may also keep it after you have left the school, where the law requires us to. In the interests of keeping this notice concise, please refer to our full Data Retention Policy and Schedule located on Chaucer College's website under the 'Privacy' tab.

8. The rights available to individuals in respect of processing

Data protection law gives individuals certain data protection rights. The rights you can exercise will depend on the lawful basis of processing (consent, contract, and so on). Your data protection rights include:

- The right to be informed.
- The right of access: you have the right to request a copy of the information that we hold about you.

- The right to rectification: you have a right to correct data that we hold about you that is inaccurate or incomplete.
- The right to erasure: in some circumstances, you can ask for the data we hold about you to be erased from our records.
- The right to restrict (stop) processing: where certain conditions apply you have a right to restrict the processing.
- The right to data portability: you may have the right to have the data we hold about you transferred to another organisation.
- Rights in relation to automated decision making and profiling.

Some of these rights may not apply where we are legally obliged to keep or share your personal data. In certain circumstances, you may have additional rights beyond those above. If you want to exercise your rights, please contact our Data Protection Officer (see above).

9. The right to object

Data protection law also gives individuals the right to object to the processing of their personal data in certain circumstances. The right to object applies when processing is based on either 'public task' or 'legitimate interests'. Chaucer College can only refuse to comply with your request if:

- We can demonstrate compelling legitimate grounds for the processing that override your interests, rights and freedoms;
- The processing is for the establishment, exercise or defence of legal claims;
- The request is manifestly unfounded; or
- The request is excessive.

We will not market our services to you in the future unless you have consented. It should be noted, however, that your right to object to processing is absolute in the case of processing for direct marketing purposes. If you want to exercise your right to object, please contact our Data Protection Officer (see above).

10. The right to withdraw consent

Chaucer College may process some personal data on the basis of your consent. You can withdraw your consent to processing at any time:

While in most cases you, or your parents/carers or representative/agency, must provide the personal data we need to collect, there are some occasions when you can choose whether, or not, to provide the data. We will always tell you if it is optional. If you must provide the data, we will explain what might happen if you do not. 12. Your right to lodge a complaint
